### The Mobile Vietnam Memorial Wall

The Mobile Vietnam Memorial Wall is a half-scale mobile replica of The Vietnam Veterans Memorial Wall in Washington, D.C. It was created by and for the Antelope Valley (hence the nickname "The AV Wall").

When the AV Wall is displayed, it is open 24 hours/day for free public viewing.

Most Walls Keep People Out, This Wall Brings People Together.

- Number of casualties on The Wall 58,281

- Highest Casualty Year 1968: 16,916
- Approximately 997 were killed on their first day in Vietnam (unconfirmed)
- Approximately 1,443 were killed on their day of departure from Vietnam (unconfirmed)

# **Veteran Spotlight** (as reported by Tim Coates)

A Marine and a brother: **Jerry Schmidt** was born on September 30, 1947, in Chicago. His family stayed there until Jerry was 8 years old before moving to the Los Angeles area. He attended Hamilton High School until graduation and then joined the Marines.

After his military service, he attended Laverne University and received a BA, then followed that with an MBA in Business. Jerry worked at Everest and Jennings for 23 years. E&J manufactured durable medical supplies such as wheelchairs. After leaving E&J, he worked for Honeywell as a Customer Service Manager and then as HR manager.

Jerry is an Honorably Discharged Marine Veteran and founding member of Rolling Thunder CA-1. He joined RT during the start-up of this organization about 10 years ago. He is on the Board of Directors and is our "Government and Veterans Affairs" committee chairperson. He keeps us up to date on Veterans issues and benefits as well as keeping count of the recovered soldiers and sailors who were classified as Missing in Action (MIA) from all wars or hostile actions. It is our Rolling Thunder mission to "Never Forget", and Jerry keeps us on our mission.

He is very recognizable with his huge, 1870's style handlebar moustache in the likes of Wyatt Earp and Sam Elliot. Of course, for every Ying there is a Yang, and for Jerry he sacrificed the hair on top of his head for perhaps the bushiest "stache" in the room. Jerry decided to cultivate something on his face that grows wild in other places!

Jerry elected to go into military service in October 1967. He had a draft notice in hand and went to the Army to fulfill his obligation to our country. There was some confusion at the check-in and after the Army physical, the Army sent him home to wait for another draft notice. Although Jerry's father had been in the Army, Jerry didn't really want to go into the Army, so by the time he got his second draft notice, with his first wife pregnant, he had used that time to join the Marine Reserves, which is a 6-year commitment to the Marine Reserve Force. The Army had a hold on him but released him to join the Marines.

He went to Marine Corps Recruit Depot (MCRD) San Diego for Boot Camp, and after completion he was sent to Camp Pendleton for further Advanced Infantry Training. During his 6 years of service, he was required to attend training one weekend per month as well as every year he went on full active duty for two weeks of additional training. Much of his training and field exercises were conducted at Camp Pendleton and Coronado, CA. He also went to Marine Base 29 Palms during the summer for desert training (you know, when it was smoking hot out there!). His jungle training was conducted at Camp Pendleton and Coronado.

Most of his specialized training and field exercises were conducted between Camp Pendleton and Coronado, CA. However, prior to attaining the rank of Corporal (E-4), Jerry was sent to MCRD San Diego to attend Non-Commissioned Officer (NCO) school.

Jerry was assigned to Amphibious Unit, 4<sup>th</sup> Division. His division had to be ready to move out at 72 hours' notice. Although his unit was not deployed, the Marines practiced their trade and trained continually on land and sea.

Training was conducted on board ship and on land in Coronado CA. with the Navy chauffeuring the Marines out to sea and dropping them into the water for a very long swim to shore. The Marines had to jump/abandon ship at sea and, while in the water, make personal flotation from the clothes they were wearing [a great survival skill if you ever get blown off the deck at sea], and then swim to shore. The water is NOT at SPA temperature out there, it's probably 52-58 degrees, and there can be some toothy critters out there. It is a double sphincter pucker to be sure, so puckered-up that breaking wind might sound like a tea kettle on the boil! Warning to sharks: Bite a Marine, loose your teeth!!

Jerry met his second wife, Carmen, in 1974. They are still married to this day. Carmen has some memory issues, and true to his character, he is her constant care giver. It takes emotional steel and incredible kindness to render that kind of care to the love of your life.


His son David is a Marine veteran and was also a founding member of RTCA1 and a Board of Directors member before moving to Tennessee. He is a mortgage broker. Jerry also has a granddaughter named Anja. Anja is a nurse practitioner. Then there is 5-year-old great granddaughter Madeliene, and 7-month-old great grandson, Boone. They live in New Hampshire.

Jerry has a few motorcycles too. He has 2 Harley Davidson Road Kings, a custom Triumph Bobber, and his new bike, a Royal Enfield. Jerry started riding motors when he was 151/2- years, just old enough to get a rider's permit. That first bike was a Honda 160 SL. Since then, he has had more Hondas and Suzuki's and two Harley Davidson Road Kings.

Jerry was involved in a crash in 2015. He was riding in a group that stopped at a light. One of the riders behind him failed to slow down and rear-ended Jerry. He received some broken ribs and other injuries but survived. His bike did not fare so well. It was totaled by the insurance company, so Jerry and David bought it back. They bought a second 2001 Road Kind for parts, but it was a running bike. They put his crashed bike back together. So, that's how you get a garage full of bikes! The real message here is to not get road hypnotized fatigue, or mesmerized, or distracted, or spot focused when on extended rides.

So, look for the burley mustached guy in the baseball cap. He looks like the consummate biker, talks softly like a best friend, and acts like a consummate brother. Jerry wears a hat to protect himself from the sun, and a smile as a good greeting. Talk to him, he is one of the good guys.
