

## **Purple Heart Day**





#### History

Commemorating the historic day in 1782 that General George Washington, Commander-In-Chief of the Continental Army, commissioned the first Purple Heart Medal, originally called the Badge of Military Merit.

The Badge of Military Merit is a purple, heart-shaped piece of silk bound with a thin edge of silver with the word merit embroidered in silver across the face. Only 3 Badges of Military Merit were awarded. The Badge of Military Merit was redesigned and re-commissioned in 1932 by General Douglas McArthur in honor of George Washington's bicentennial birthday. Now known as the Purple Heart Medal – it is the oldest military award, first being awarded to soldiers in World War I and still given to soldiers today.

A presidential order signed in 1942 permitted the Purple Heart Medal to be awarded to all branches of the military including the U.S. Coast Guard. It was World War II, when the qualification to receive the Purple Heart Medal changed to honor those who were wounded or killed in combat – that is why it's recipients often call it "the medal that nobody wants". It is unknown how many soldiers actually received it.

#### Criteria

The Purple Heart has a long list of criteria for eligibility-too long to list here. But in general, it may be awarded to members of the Armed Forces of the United States who have been wounded, killed in action, or have died or may die from wounds received in any action against the United States, action with an opposing armed force, the results of any hostile "foreign force" and many other situations where men and women in uniform may find themselves under attack.

In general, the Purple Heart is awarded for injuries sustained because of an enemy attack. Injuries sustained for other reasons not related to things "not caused by enemy agents" are generally not acceptable as grounds for receiving the Purple Heart, though friendly fire injuries do qualify if the friendly fire was intended for the enemy. The Purple Heart is now given to persons who are injured, wounded, or died while a prisoner of war (POW).

On this day, let's all remember to pay our respects to fallen soldiers, to listen to the stories of soldiers and veterans, and to thank them for their service to the nation.



# **Veteran Spotlight** (as reported by Tim Coates)

Getting to know your buddy Pat Connolly. Pat Connolly is our Rolling Thunder CA1 Chairman of the Board and an Air Force veteran, retired. He is also a founding / Charter member of the organization, having joined in 2012. He has a beguiling personality and a very dry sense of humor. He will say something that causes an uncomfortable and dramatic pause in the conversation and just let it sit and stew for what seems like forever before laughing. It's a gotcha moment.

Pat was born March 31, 1965, and grew up in St. Paul, Minnesota. He attended St. Agnes High School in St. Paul. While there he learned some stuff, played a lot of baseball at second base and short stop, and beat the drums in the High School band. That may explain why some of the marching band couldn't stay in step! Okay, kidding! After High School in 1983, Pat joined the Air Force. He was on active duty from 1983 until 1991, and then from 1993 until 2008 he was in the Air Force reserves. Pat received his Honorable Discharge and full retirement in 2008.

He was stationed at various Air Force bases (AFB) while on active duty serving our country. He was sent to Clark AFB in the Philippines, Beale AFB in California, Kunsan Air Base in Korea, and Edwards AFB California. Pat was fortunate enough to become a K-9 handler for the Air Force Military Police. Through his work ethic, he was recognized and promoted to an E-7 Master Sergeant and Law Enforcement Supervisor to Squadron Assistant Operations Superintendent.

While in the Air Force reserves, Pat joined the Ventura County Sheriff's Department and was a patrol officer. He retired after more than 25 years of police work as a Deputy Sheriff. It's not easy being the spouse of a law enforcement officer (LEO) because the work doesn't always stay in the patrol car (the patrol person's office). Lisa has been his constant companion through hard days and happy days.

Pat has been married 3 times: once from 1991-1993 (divorced in 1994), the second marriage from 1994-2008 (divorced), and he is presently (and permanently!) married to Lisa (Rolling Thunder BOD Treasurer). He has one stepdaughter. Pat and Lisa's beloved dog, Cambria, passed recently after a loving fourteen years of life. They are now blessed with a husky named Zasha as well as their cat, Raven.

Lisa and Pat love to travel. Pat said another favorite trip that he and Lisa went on has been a 10-day land tour of Italy. They are hoping to get to Ireland in a future trip. Pat and Lisa are also looking forward to taking some cruises. No sleeping on the ground in a tent for them!

Pat and Lisa are riders, and Pat has had a variety of two wheelers. When he was 16 years old his first bike was a Suzuki 125, something between a dirt bike and a street bike.
